## INVITATION TO BID

- 1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2014, intends to apply the sum of
  - a. <u>Three Million Ninety Three Thousand One Hundred Thirty One and 79/100 (Php 3,093,131.79) pesos</u> being the Approved Budget for the Contract (ABC) to payments under contract for <u>Proposed Construction of Main Drainage Canal at Heritage Subd.</u>, <u>Longos</u>, <u>Malolos City</u>. Source of Fund, 20% Development Fund.
  - b. Nine Million Nine Hundred Ninety Eight Thousand Five Hundred Twenty Three and 48/100 (Php 9,998,523.48) pesos being the Approved Budget for the Contract (ABC) to payments under contract for Proposed Asphalt Overlaying/Patching of Road at Brgy. Ligas, Malolos City. Source of Fund 20% Development Fund.
  - c. One Million Five Hundred Thirty Thousand pesos (Php 1,530,000) being the Approved Budget for the Contract (ABC) to payments under contract for <u>Purchase of Six (6) Units Japan Reconditioned Suzuki Carry FB Body</u>. Source of Fund General Fund.

Individual bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from Mark Lester Santos and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Ten thousand pesos (Php 10,000.00) for project b and Five Thousand (Php 5000.00) pesos for project a and c.
- 6. The City Government of Malolos will hold a **Pre-Bid Conference** on <u>June 4, 2014, 11am</u> at <u>Malolos Sports and Convention Center, Bulihan, Malolos City</u>, which shall be open only to all interested parties who have purchased the Bidding Documents.
- 7. Bids must be delivered on or before <u>June 19, 2014, 9am</u> at <u>Malolos Sports and Convention Center</u>, <u>Bulihan, Malolos City</u>. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on <u>June 19, 2014, 10am</u> at <u>Malolos Sports and Convention Center</u>, <u>Bulihan</u>, <u>Malolos City</u>.

Late bids shall not be accepted.

- 8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
