This CONTRACT AGREEMENT made on the ____ day of _____ 2017 between the **CITY GOVERNMENT OF MALOLOS (CGM)** (hereinafter called the "Entity") and **P.I. FARM PRODUCTS, INC.** with office address at 35 F. Alarcon St., Sto. Rosario, Maysan Valenzuela City (hereinafter called the "Supplier");

WHEREAS, the Entity, through BAC Resolution No. 2017-0221-2, awarded the contract to the Supplier for the Supply of Four (4) Units of Hand Tractor in the amount of Five Hundred Nineteen Thousand Eight Hundred Pesos (P519,800.00), inclusive of all applicable taxes and fees (hereinafter called the "Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - b. The Supplier's Price Quotation, attached as Annex B; and
 - c. The Entity's Notice of Award, attached as **Annex C**.
2. In consideration of the payment to be made by the Entity to the Supplier, the Supplier hereby covenants with the Entity to provide the goods, and remedy any defects therein in conformity with the provisions of this contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
3. The Entity hereby covenants to pay the Supplier the Contract Price in consideration of the provision of goods and the remedying of defects thereof.

IN WITNESS WHEREOF, the parties hereto have caused these presents to be signed by their respective duly authorized representatives on the date abovementioned.


