Contract Agreement for Goods

This CONTRACT AGREEMENT made on the ____ day of 07 MAR 2017 2017 between the **CITY GOVERNMENT OF MALOLOS (CGM)** (hereinafter called the "Entity") and **P.N. ALCARAZ GENERAL MDSE.** with office address at P. Damaso St., Concepcion, Baliuag, Bulacan (hereinafter called the "Supplier");

WHEREAS, the Entity, through BAC Resolution No. 2017-0221-3, awarded the contract to the Supplier for the **SUPPLY OF 50 SETS OF FISHING GEARS AND PARAPHERNALIA (GILLNETS, HEAVY DUTY ICE CHEST AND 6.5 HP MOTOR ENGINE)** in the amount of **Seven Hundred Forty Nine Thousand Eight Hundred Eight Pesos (Php 749,808.00)** inclusive of all applicable taxes and fees (hereinafter called the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents shall form part of this Agreement in accordance with Section 37.2.3 of the Revised Implementing Rules and Regulations of RA No. 9184, viz:
 - a. The Entity's Terms of Reference, attached as **Annex A**;
 - b. The Supplier's Price Quotation, attached as Annex B; and
 - c. The Entity's Notice of Award, attached as **Annex C**.
2. In consideration of the payment to be made by the Entity to the Supplier, the Supplier hereby covenants with the Entity to provide the goods, and remedy any defects therein in conformity with the provisions of this contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
3. The Entity hereby covenants to pay the Supplier the **Contract Price** in consideration of the provision of goods and the remedying of defects thereof.


