## BIDS AND AWARDS COMMITTEE INVITATION TO BID

1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2017 and Department of Social Welfare and Development (DSWD) - intends to apply the sum of:
  - a. Six Million Nine Hundred Sixty Four Thousand Two Hundred Pesos (Php 6,964,200.00) being the Approved Budget for the Contract (ABC) to payments under contract for 2017 Supplemental Feeding Program in Day Care Centers in the City of Malolos. Source of Fund – DSWD.
  - b. Five Million Three Hundred Seventy Three Thousand Seven Hundred Ninety One and Six Centavos (Php 5,373,791.06) being the Approved Budget for the Contract (ABC) to payments under contract for the Proposed Construction of Two (2) Storey – Four (4) Classroom Building at Brgy. Atlag, City of Malolos. Source of Fund – SEF).
  - c. Five Million Three Hundred Ten Thousand One Hundred Seventy Eight Pesos and Forty Two Centavos (Php 5,310,178.42) being the Approved Budget for the Contract (ABC) to payments under contract for the Proposed Construction of Two (2) Storey – Four (4) Classroom Building at Brgy. Matimbo, City of Malolos. Source of Fund – SEF).
  - d. One Million Three Hundred Ninety Eight Thousand Seven Hundred Ten Pesos and Five Centavos (Php 1,398,710.05) being the Approved Budget for the Contract (ABC) to payments under contract for the Proposed Construction of Health Center at St. Ignatius Subd., Brgy. Mabolo, City of Malolos. Source of Fund – 20% Development Fund
  - e. One Million Ninety Seven Thousand Six Hundred Seventeen Pesos and Eighty Six Centavos (Php 1,097,617.86) being the Approved Budget for the Contract (ABC) to payments under contract for the Proposed Installation of Lighting Facility, Bangkal/Santor Diversion Road, City of Malolos. Source of Fund – General Fund

Individual bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Engr. Benjamin M. Ilag, BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of ten thousand pesos (Php 10,000.00) for items a, b and c and five thousand pesos (Php 5,000.00) for items d and e.
6. The City Government of Malolos will hold a Pre-Bid Conference on August 3, 2017, 10:00 a.m. at Malolos Sports and Convention Center, Bulihan, City of Malolos, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered on or before August 18, 2017, 10:00 a.m. at Malolos Sports and Convention Center, Bulihan, City of Malolos. Submission of bids after 10:00 a.m. will not be allowed. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on August 18, 2017, 10:01 a.m. at Malolos Sports and Convention Center, Bulihan, City of Malolos.

Late bids shall not be accepted.

8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
