**INVITATION TO BID**

1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2016, intends to apply the sum of:
  - a. Six Million Six Hundred Ninety Six Thousand Nine Hundred Ninety Six pesos and 76/100 centavos (Php 6,696,996.76) pesos, being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Construction of Two (2) Storey – Four (4) Classroom Bldg. at Brgy. Namayan, City of Malolos. Source of fund – General Fund.
  - b. Five Million Four Hundred Thirty Six Thousand Seven Hundred Seventy Eight pesos and 65/100 centavos (Php 5,436,778.65) pesos, being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Construction of Rural Health Unit VII at Brgy. Mojon, City of Malolos. Source of fund – 20% Development Fund.
  - c. Four Million Six Hundred Six Thousand Two Hundred Sixty Seven pesos and 99/100 centavos (Php 4,606,267.99) being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Construction of Drainage at Northville 8, Brgy. Santor, City of Malolos. Source of fund – 20% Development Fund.
  - d. Three Million Four Hundred Fifty Nine Thousand Seven Hundred Sixty pesos and 19/100 centavos (Php 3,459,760.19) pesos, being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Concreting of Road at St. Paul Subd., Brgy. Sumapang Matanda, City of Malolos. Source of fund – 20% Development Fund.
  - e. Two Million Eight Hundred Fifty Thousand pesos (Php 2,850,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Payment for the purchase of three (3) units Brand New Mini Dump Truck – Six (6) Wheeler for the use of City General Services Office. Source of fund – General Fund.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid item/s. Delivery of the Goods is required within 30 calendar days. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from **Mark Lester Santos** and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (P10,000.00) for items a & b** and **Five thousand pesos (Php 5,000.00) for items c, d & e**.
6. The City Government of Malolos will hold a **Pre-Bid Conference** on February 29, 2016, 11:00 am at Malolos Sports and Convention Center, Bulihan, Malolos City, which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered on or before March 14, 2016, 9:00 am at Malolos Sports and Convention Center, Bulihan, Malolos City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on March 14, 2016, 10:00 am at Malolos Sports and Convention Center, Bulihan, Malolos City.

Late bids shall not be accepted.

8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
