INVITATION TO BID

1. The City Government of Malolos, through the budget from the Trust Fund Aid of the Department of Social Welfare and Development (DSWD) for Supplementary Feeding Program (SFP) for 2016 intends to apply the sum of Six Million Eight Hundred Thirty Two Thousand Seventy Three Pesos (Php 6,832,073.00) being the approved budget for the contract (ABC) under the contract for City Social Welfare and Development Office (Feeding Program for Daycare Children).

Individual bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid items. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Mark Lester Santos and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Ten thousand pesos (10,000.00).
6. The City Government of Malolos will hold a **Pre-Bid Conference** on October 12, 2016, 11am at Malolos Sports and Convention Center, Bullhan, Malolos City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered on or before October 25, 2016, 9am at Malolos Sports and Convention Center, Bullhan, Malolos City. All bids must be accompanied by a bid security in any of the acceptable forms and amount. Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on October 25, 2016, 10am at Malolos Sports and Convention Center, Bullhan, Malolos City.

Late bids shall not be accepted.

8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
