INVITATION TO BID

1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2015 and Budget from the Trust Fund Aid of the Department of Social Welfare and Development (DSWD) for Supplementary Feeding Program (SFP) for 2015, intends to apply the sum of:
 - a. Two Million Twelve Thousand Three Hundred Eighty Three and 55/100 (Php 2,012,383.55) pesos being the Approved Budget for the Contract (ABC) to payments under contract for Proposed Construction of Additional Facilities (Brgy. Health Center), Brgy. Sto. Rosario, Malolos City. Source of Fund – 20% Development Fund (Barangay).
 - b. Five Million Six Hundred Fifty Six Thousand Five Hundred Fifty Three (Php 5,656,553.00) pesos being the Approved Budget for the Contract (ABC) to payments under contract for CSWD Office Feeding Program for Day Care Children. Source of Fund – Trust Fund Aid of DSWD for Supplementary Feeding Program 2015.

Individual bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Mark Lester Santos and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand Pesos (Php 5,000.00) for item a and Ten Thousand Pesos (10,000.00) for item b.
6. The City Government of Malolos will hold a **Pre-Bid Conference** on June 18, 2015, 11am at Malolos Sports and Convention Center, Bulihan, Malolos City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered on or before July 7, 2015, 9am at Malolos Sports and Convention Center, Bulihan, Malolos City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on July 7, 2015, 10am at Malolos Sports and Convention Center, Bulihan, Malolos City.

Late bids shall not be accepted.

8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
