INVITATION TO BID

1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2017 and Trust Funds from National Agencies, intends to apply the sum of:
 - a. Seven Million Nine Hundred Forty Five Thousand Two Hundred Five Pesos and 76/100 Centavos (Php 7,945,205.76) being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Construction of Two (2) Storey – Six (6) Classroom Building at Brgy. Guinhawa, City of Malolos. Source of fund – SEF.
 - b. Six Million Four Hundred Fifty Six Thousand Seven Hundred Thirteen Pesos and 83/100 Centavos (Php 6,456,713.83) being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Safe Closure and Rehabilitation Plan of Material Recovery Facility at CMRF, Brgy. Mambog, City of Malolos. Source of fund – Trust Fund (DENR).
 - c. Three Million One Hundred Ninety Two Thousand Nine Hundred Pesos (Php 3,192,900.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Purchase of Medicines for the Use of City Health Office, City of Malolos. Source of fund – General Fund.
 - d. Two Million Nine Hundred Nineteen Thousand Four Hundred Fifty Pesos (Php 2,919,450.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Purchase of Laboratory Machines and Supplies for the use of City Health Office, City of Malolos. Source of fund – General Fund.
 - e. Two Million Four Hundred Twenty Six Thousand Nine Hundred Ninety Nine Pesos and 40/100 Centavos (Php 2,426,999.40) being the Approved Budget for the Contract (ABC) to payments under the contract for the Purchase of Supplies and Equipment under the Livelihood Projects (DILEEP-Kabuhayan). Source of fund – Trust Fund - DOLE.
 - f. Two Million Four Hundred Three Thousand Nine Hundred Fifty Five Pesos and 50/100 Centavos (Php 2,403,955.50) being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Painting and Replacement of MCRF Building Roofing at MCRF Compound, Brgy. Mambog, City of Malolos. Source of fund – General Fund.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid item/s. Delivery of the Goods is required within 30 calendar days. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from Mr. Mark Lester S. Santos/Engr. Benjamin M. Ilag and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Ten Thousand Pesos (P10,000.00) for items a & b and Five Thousand Pesos (P5,000.00) for c, d, e & f.
6. The City Government of Malolos will hold a **Pre-Bid Conference** on February 20, 2017, 11:00 am at Malolos Sports and Convention Center, Bulihan, Malolos City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered on or before March 7, 2017, 9:00 am at Malolos Sports and Convention Center, Bulihan, Malolos City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on March 7, 2017, 10:00 am at Malolos Sports and Convention Center, Bulihan, Malolos City.

Late bids shall not be accepted.

8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
