**INVITATION TO BID**

1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2015, intends to apply the sum of:
  - a. Two Million Ninety Nine Thousand Eight Hundred Fifty Seven and 34/100 (Php 2,099,857.34) pesos being the Approved Budget for the Contract (ABC) to payments under contract for Proposed Rehabilitation of Road at Brgy. Pamarawan, Malolos City. Source of Fund –General Fund.
  - b. Three Million One Hundred Thirty Eight Thousand Five Hundred Ninety Seven and 15/100 (Php 3,138,597.15) pesos being the Approved Budget for the Contract (ABC) to payments under contract for Proposed Concreting of Road leading to MRF, Brgy. Mambog, Malolos City. Source of Fund – 20% Development Fund.
  - c. Four Million Four Hundred Sixty Nine Thousand Four Hundred Sixteen and 93/100 (Php 4,469,416.93) pesos being the Approved Budget for the Contract (ABC) to payments under contract for Proposed Upgrading of Road and Drainage at Kap. Kiko, Brgy. San Agustin, Malolos City. Source of Fund – 20% Development Fund.
  - d. Eight Million One Hundred Eighty One Thousand Two Hundred Fifty Five and 75/100 (Php 8,181,255.75) pesos being the Approved Budget for the Contract (ABC) to payments under contract for Proposed Construction of Malolos Public Market (Back to Back Section, Brgy. San Vicente, Malolos City. Source of Fund – Bank Loan.
  - e. Nine Million Nine Hundred Twenty Six Thousand Three Hundred Twelve and 30/100 (Php 9,926,312.30) pesos being the Approved Budget for the Contract (ABC) to payments under contract for Proposed Construction of Two (2) Storey Four (4) Classroom, One (1) Unit Stage and Site Development at Pamarawan High School, Brgy. Pamrawan, Malolos City. Source of Fund – School Education Fund.

Individual bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Mark Lester Santos and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five thousand pesos (Php 5,000.00) for items a,b and c and Ten thousand pesos (10,000.00) for items d and e.
6. The City Government of Malolos will hold a **Pre-Bid Conference** on May 27, 2015, 11am at Malolos Sports and Convention Center, Bulihan, Malolos City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered on or before June 9, 2015, 9am at Malolos Sports and Convention Center, Bulihan, Malolos City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on June 9, 2015, 10am at Malolos Sports and Convention Center, Bulihan, Malolos City.

Late bids shall not be accepted.

8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
