## BIDS AND AWARDS COMMITTEE INVITATION TO BID

1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panlungsod for 2017, Department of Social Welfare and Development (DSWD) – Bottom-Up Budgeting, Department of Education (DepEd) Bottom-Up Budgeting and Department of Health (DOH) Bottom-Up Budgeting - intends to apply the sum of:
  - a. **Two Million Two Hundred Thirty Three Thousand One Hundred Twenty Pesos (Php 2,233,120.00)** being the Approved Budget for the Contract (ABC) to payments under contract for **Purchase of Certified Seeds for 2017 Wet Cropping Season Palay Production in the City of Malolos**. Source of Fund –General Fund.
  - b. **One Million Four Hundred Twenty Eight Thousand Five Hundred Ninety Two Pesos (Php 1,428,592.00)** being the Approved Budget for the Contract (ABC) to payments under contract for **Provision of ECCD Materials, Supplies, Instruments and Books**. Source of Fund – DSWD-Trust Fund-Bottom-Up Budgeting and General Fund – Counterpart (Php1,796.00).
  - c. **One Million Four Hundred Thousand (Php 1,400,000.00)** being the Approved Budget for the Contract (ABC) to payments under contract for **Purchase of School Furnitures (Seats/Arcmchairs)**. Source of Fund – DepEd-Trust Fund-Bottom-Up Budgeting.
  - d. **One Million Four Hundred Thirty Thousand Nine Pesos and 31/100 centavos (Php 1,430,009.51)** being the Approved Budget for the Contract (ABC) to payments under contract for **Expansion of Rural Health Units – Lactation Station and Milk Bank**. Source of Fund – DOH-Trust Fund-Bottom-Up Budgeting and General Fund - Counterpart (Php 350,009.51)

Individual bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Engr. Benjamin M. Ilag, BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during working days.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five thousand pesos (Php 5,000.00) for items a, b, c and d.
6. The City Government of Malolos will hold a **Pre-Bid Conference on June 29, 2017 at Malolos Sports and Convention Center, Bulihan, City of Malolos**, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered on or before **July 14, 2017, 10:00 a.m.** at **Malolos Sports and Convention Center, Bulihan, City of Malolos**. Submission of bids after 10:00 a.m. will not be allowed. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidders' representatives who choose to attend bid opening on **July 14, 2017, 10:01 a.m.** at **Malolos Sports and Convention Center, Bulihan, City of Malolos**.

Late bids shall not be accepted.

8. The City Government of Malolos reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
